THE CONCEPTUAL BASES OF STATE REGULATION OF THE NATIONAL SECURITY

Keywords: state regulation, social values, national security, external and internal factors.

National security directly contacts with the social values. However it is necessary to consider that perception and understanding of national values and ideals by the specific subject in concrete time was and will be different.

The strategy of national security has to be considered in dynamics as, representing one of the practical embodiments of subjective representations it can't but change with changes of international and interstate situation.

The majority of the existing definitions reveal the separate parties of the national security phenomenon. So, the statement that security is one of the most important living conditions of any system is quite fair. But, representing the condition of achievement of the goal, security at the same time reflects a certain condition of social system and is directly connected with protection of the state interests [1, 2] .

The concept "national security" covers also the following aspects of activity: " life health, rights and personal freedoms, property and security protection of society and state from criminal encroachments", "nuclear security", "radiation security of population", "military security", "information security", "ecological security", "traffic security", "aviation security", "naval security", "food security", etc.

Thus, national security as the social phenomenon has a set of the variations fixed by the right as the condition which accumulates a set of types of harm and also possible ideas of threats and their consequences [2].

National security is the synthesis of state and public security where the state security acts as means, and public security is the purpose of definition and protection of the vital interests of citizens.

Summing up the above stated, it should be noted that national security represents:

- Internal factors: territory state sizes; presence of natural resources; population of the country, its military and political, economic and scientific and technical capacity; stability of the state institutes; moral spirit of society, its unity;

- External factors: geopolitical position of the state in the world; participation in international organizations and military and political unions; presence of allies and opponents or their lack; extent of control over the world sources of raw materials, gold and foreign exchange reserves; possession of advanced technologies, information resources, etc.

ANALYSIS OF ASPECTS OF STATE LEGAL SUPPORT IN THE FIELD OF NATIONAL AND PUBLIC SECURITY IN UKRAINE

The comprehensive development of the state of Ukraine is impossible without the provision of appropriate state legal support in the field of national security, as well as the unified stable and functional system of internal affairs, which is the part of the national security sector, and in the field of public security taking into account recent tendencies and innovations in the country's regulatory and legal framework.

The national security of Ukraine is the protection of state sovereignty, territorial integrity, democratic constitutional order and other national interests of Ukraine from real and potential threats [3]. It should be noted that the Strategy for the Development of the Ministry of Internal Affairs of Ukraine until 2020 [2] contains a different definition (public security). In this regard, we believe that the terminological apparatus of these normative legal acts should be agreed upon.
